

(Under Rule No. 32 of L.R.R.)

According to the orders contained in G.R. referred to above, the Collector of Kolhapur is pleased to grant revenue free under rule 32 I.R. Rules to the Swami Vivekanand Shikshan Sanstha, Kolhapur of land measuring 6 Acres 12 Gunthas 28.2/9 Sq. Yards out of Plot 'D' from S.No. 204A of Kolhapur, Taluka and District Kolhapur valued as a revenue free holding for the purpose of construction of college building, subject to the conditions laid down in the rule 36(1), Land Revenue Rules and to the following further conditions:

- 1) that the college building should be constructed within two years from the date of handing over possession of the land to Shri Swami Vivekanand Shikshan Sanstha, Kolhapur.
- 2) that the Plan of the building should be got approved by the Asstt. Director of T. Planning, Kolhapur and the Collector and no additions or alterations should be made to the building without prior permission of the Collector.
- 3) that the college should be kept open to all irrespective of caste and creed.
- 4) that the land and building thereon should be used for purpose for which the grant is made and for no other purpose and that no profit should be made out of the same.
- 5) that the grant should be conditional upon the continued recognition of the college by the Shivaji University, Kolhapur.
- 6) that the building to be constructed shall comply with the prevention of Urban Development Rules in force.
- 7) that the grant shall be liable to be revoked and the land resumed without payment any compensation for breach of any of the conditions.
